

- (1) The dumpster or commercial trash receptacle will not be situated on any curb or roadway or otherwise block any portion of a motorway or pose a hazard to or otherwise interfere with traffic;
- (2) The dumpster or commercial trash receptacle will not be situated at or so near to an intersection as to create an actual or potential safety hazard;
- (3) The dumpster or commercial trash receptacle will not encroach upon the curb or any other paved portion of any right of way of the City of Ringgold unless the applicant makes a showing of hardship, based on the special conditions of the property in question or for reasons of health and safety, that it cannot so comply and pays to the City a fee to cover the cost of any encroachment as determined by the Mayor and Council;
- (4) The dumpster or commercial trash receptacle will be maintained in accordance with the rules and regulations of the Catoosa County Health Department;
- (5) Foul odors emanating more than fifty (50) feet from the dumpster or commercial trash receptacle will be quelled within a reasonable time of the person's or business' notice thereof;
- (6) Leakage, trash, and litter arising from the dumpster or commercial trash receptacle will be cleaned up within a reasonable time of occurrence;
- (7) Only materials allowed by State law will be placed in the dumpster or commercial trash receptacle; and
- (8) No residential or commercial garbage from outside the City limits will be deposited anywhere within the City limits, including dumpsters and commercial trash receptacles.
- (9) All dumpsters or commercial trash receptacles shall be enclosed with solid fencing, walls, and/or other barriers such that visibility of and emission of odors from each dumpster or commercial trash receptacle is minimized
