- 1. Council approved Work Session Minutes from July 14, 2014 Work Session.
- 2. Council approved Minutes from July 14, 2014 Regular Council Meeting.
- 3. Council voted to follow protocol on Debris Resolution regarding the removal of excess dirt on tile on Skip Patty's yard on Mountain Street..
- 4. Council approved Talley Construction Co. Inc.'s bid for \$82,893.20 for the Tennessee Street Site Development to be funded by the Downtown Development Authority.
- 5. Council voted to approve Kellie Floyd's request to be annexed and zoned as an R-1 property.
- 6. Council approved CTI's Pedestrian Light Engineering Amendment to prepare plans and submit DOT permitting for a fee of \$1,800.00.
- 7. Council approved the purchase of a new sand filter for the City of Ringgold Pool in the amount of \$14,998.87 from Recreonics.
- 8. Council voted to approve the bid from Calhoun Meter in the amount of \$55,648.92 for the Ooltewah-Ringgold Road Waterline Replacement Parts project.
- 9. Council approved the bid of \$290,080.12 from Talley Construction for the SR3/US41 at Tiger Creek DOT Sewer Relocation project.
- 10. Council voted to approve a Motion of Intent regarding a 3% (2.763) increase to the 2014 Tax Millage Rate for the purpose of advertising the five-year history.
- 11. Council approved the grant contract from Lyndhurst Foundation in the amount of \$23,000.00 and made bid award for the Canoe Launch and Nature Trail.
- 12. Council voted to rescind Ordinance No. 2006-0327-02 which establishes guidelines regarding the political activities of City employees. Council also voted to implement policies for City staff in regards to political activity.
- 13. Council approved Rindt-McDuff Associates, Inc.'s proposal to handle the bidding process for sidewalks for Nashville Street and High Street and Highway 151 to Guyler street at the cost of \$8,850.00.
- 14. Council approved the purchase of a new lawn mower from the low bidder, B&B Tractor in the amount of \$11,151.18.

- 15. Council voted to put the Façade Requirements per Zoning Ordinance on the next work session, August 7, 2014, and then send it to the Planning Zoning Commission for further study.
