#### **BID SPECIFICATIONS**

Awards will be made to the best responsible bidder as determined by the City of Ringgold. The quality of the articles to be supplied, their conformity with the specifications, their suitability to requirements, experience and delivery terms shall be taken into consideration.

The City may consider Award of the Contract to other than the low Bidder.

Successful bidder will provide all materials and installation for this project. The location of City Hall is 150 Tennessee Street, Ringgold, GA. An onsite visit is recommended – contact Dexter Coley at 423-504-2954.

The City of Ringgold hereby solicits and requests sealed bids for materials and installation/repair of dormers and railings at Ringgold City Hall.

## Required Repair Scope:

- 1. Remove and dispose of all existing siding, trim, mouldings, fascia, flashings & soffits at (15) fifteen existing dormers. Install new fiber cement siding and PVC trims to match existing. Replace flashings, prep, prime & paint dormers with Sherwin Williams Super Paint Exterior "Gloss White" or equal. Dormers are 48" wide, 84" tall and 84" deep.
- 2. Repair, caulk, putty, prep, prime & repaint 208 linear feet of 3' tall baluster on the roof.
- 3. Re-caulk & repaint all exterior columns, trim, freize, fascia, soffit and mouldings. Caulking of column shafts to bases is specifically included.
- 4. All lifts, hoisting or other measures required to perform the work shall be included.
- 5. All temporary safety and protection measures for workman and the public shall be included.
- 6. All on-going and final cleaning shall be included.
- 7. Provide an add alternate to re-roof the existing building with charcoal architectural shingles to match. Shingles shall be I-90 with a 20 year warranty. All removal & disposal of existing shingles, felt & damaged substrate shall be included.

## STANDARD WARRANTY ON ALL WORK:

- A. Contractor shall issue a two-year warranty against defects in installed materials and workmanship.
- B. No dollar limitation on any of the above warranties.

Box 579, Ringgold, Ga. 30736 or hand delivered to the City Hall at 150 Tennessee St., Ringgold, Ga. All bids shall be received on or before the above designated date and time. Any bid received after this date and time shall not be accepted. Bids shall be typed or submitted in ink. Bids will be opened and read publicly. Bids are legal and binding upon the bidder when submitted.

It is understood that this contract, if accepted by the City of Ringgold, is entered into solely for the convenience of the City and in no way precludes the City from obtaining like goods from other suppliers upon prior approval of the City Manager. Such approval shall be made at the sole discretion of the City of Ringgold and shall be conclusive.

The City of Ringgold reserves the right to accept or reject any or all bids for any reason, to waive technicalities, and to make an award deemed in its best interest. The City of Ringgold shall have the right to delete a unit item from the bid if necessary or proper in the sole determination of the City of Ringgold.
