All contractors must provide adequate proof of workers compensation and general liability for all employees and equipment of the contractor. Contractor is to provide all labor, equipment and materials for entire project.



- Material and installation of beige PVC slats in six (6) foot tall fencing
- Material and installation of single swing gates
- Material and installation of five (5) foot tall double swing gate with spring loaded closer and hardware
- Material and installation of six (6) foot tall double swing gate with latch/lock hardware
