BID SPECIFICATIONS

Awards will be made to the best responsible bidder as determined by the City of Ringgold. The quality of the articles to be supplied, their conformity with the specifications, their suitability to requirements, experience and delivery terms shall be taken into consideration.

The City may consider Award of the Contract to other than the low Bidder.

Successful bidder will provide all materials and installation for this project. The location of City Hall is 150 Tennessee Street, Ringgold, GA. An onsite visit is recommended – contact Stephen Middlebrooks at 706-428-1740.

The City of Ringgold hereby solicits and requests sealed bids for materials and installation/repair of Martha Denton Pool. The location of the Martha Denton Pool is 406 Cotter Street, Ringgold Georgia 30736.

Required Repair Scope:

1. Remove Waterline tile
2. Remove Gutter tile and coping tile lip
3. Build up void where waterline tile is gone and patch all holes present
4. Sandblast existing painted surface of pool
5. Repair all cracks in Pool
6. Replace Rope Anchors at break point
7. Cut 18-24" trench around pool perimeter to replace plumbing
8. Replace return line plumbing and fill trench with concrete
9. Perform pressure test on all plumbing to ensure leak free
10. Replace or extend all return fittings in pool and add return wall fittings with female threads
11. Add Directional eyeballs to all returns
12. Add Additional steps to shallow end or pool
13. Add All applicable handrails per GA Health Code
14. Add Thermoplastic, non-skid "coping" surface to trenched plumbing area to extend to edge of Gutter System
15. Replace all Marker tiles in pool with # Tile, FT tile, International NO DIVE tile (where applicable for NO DIVE)
16. Add Non-skid marker tile in same configuration as waterline marker tiles in Coping on decking
17. Apply Thermoplastic or similar surface to entire pool up to waterline in contrasting color to Gutter surface
18. Add additional hydrostatic valves in pool floor and replace existing hydrostatic valves in bottom drains
19. Replace Main Drain covers with VGBA-compliant covers
20. Pool Interior surface to be white background per GA Health Code
21. Add Zero Entry to shallow end of pool

STANDARD WARRANTY ON ALL WORK:

- A. Minimum 10-year warranty on surface and all materials. Contractor shall issue a two-year warranty on workmanship. No dollar limitation on any of the above warranties.

Sealed bids shall be addressed to the **Attention of City Manager, Dan Wright** and mailed to the City of Ringgold, P.O. Box 579, Ringgold, Ga. 30736 or hand delivered to the City Hall at 150 Tennessee St., Ringgold, Ga. All bids shall be received on or before the above designated date and time. Any bid received after this date and time shall not be accepted. Bids shall be typed or submitted in ink. Bids will be opened and read publicly. Bids are legal and binding upon the bidder when submitted.

It is understood that this contract, if accepted by the City of Ringgold, is entered into solely for the convenience of the City and in no way precludes the City from obtaining like goods from other

suppliers upon prior approval of the City Manager. Such approval shall be made at the sole discretion of the City of Ringgold and shall be conclusive.

The City of Ringgold reserves the right to accept or reject any or all bids for any reason, to waive technicalities, and to make an award deemed in its best interest. The City of Ringgold shall have the right to delete a unit item from the bid if necessary or proper in the sole determination of the City of Ringgold.
